Dear Blue Bug Tours Team,

We hereby bindingly book our participation in the **FUSCA PANTANAL 2025** as a one-way-trip from Curitiba to Campo Grande.

Return journey:	25.10.2025	from Campo Grande

The entry fee is € 6,900.00 (early bird rate) for bookings made by 31.01.2025¹ .

This entry fee includes

- hotel accommodation in a double room incl. breakfast for two people from 12.10.2025 to 25.10.2025 (15 nights),
- the tour vehicle (a Beetle from the 70s or 80s) including insurance (third party liability),
- the tour-guiding (in English, if necessary also in German), route-information and support, as far as possible,
- an escort vehicle and
- tour-labels, some give-aways and a very, very good time.

The ride is neither a racing event nor a competition. The tour is a social community activity. Depending on local conditions (e.g. weather), Blue Bug Tours reserves the right to adapt the route or cancel sections at any time. We ride in groups / groups. Our tour vehicle is approved for road traffic and has the required operating license.

After registration, we will receive an invoice for a deposit of € 1,200.00. If this is not paid within 14 days, our registration will be canceled and the booking space will be released again. The final payment must be made by 30.04.2025.

General Terms and Conditions

1. Scope of application

These General Terms and Conditions (GTC) are also to be understood as conditions of participation and govern the relationship between Blue Bug Tours (hereinafter "Organizer") and its customers (hereinafter "Participants") who participate in road trips (hereinafter also "Excursions") of Blue Bug Tours and, if applicable, use vehicles arranged for rental by Blue Bug Tours (currently possible on the CONO SUR 2024 and the FUSCA PANTANAL 2025).

By registering to participate in Blue Bug Tour Road-Trips, participants accept the present General Terms and Conditions. These T&Cs and conditions of participation apply to all agreed registrations and bookings and do not permit any ancillary provisions drafted by the participant.

2. Participation fees, bookings and payment

2.1. The booking of a road trip / excursion with Blue Bug Tours can only be made online via info@bluebugtours.com. Registration is binding upon receipt of the registration email and is considered confirmed by the organizer upon receipt of the invoice.

2.2. The participation fee is due in part or in full (depending on the tour selected) in accordance with the invoice specifications and must be transferred to the account of Blue Bug Tours by bank transfer. Blue Bug Tours reserves the right to withdraw from the reservation / confirmation of participation if the deadline is not met. The organizer also reserves the right to change the prices at any time. Bookings already made will be charged at the participation fees valid at the time of booking.

2.3. The participation fee includes the legally applicable value added tax.

2.4. The participation fee includes the services listed in the registration form.

2.5. All services / costs not listed under 2.4, such as meals, any tolls, ferries or special trips, shall be borne by the participant. Attention is drawn to the special and country-specific requirements (health insurance cover, vaccination cover, travel cancellation cover, travel costs, VISA costs if applicable, etc.).

2.6 Additional special events will be offered at some stage destinations / stations (CONO SUR 2024, FUSCA PANTANAL 2025). These are not included in the participation fees and can be adjusted and / or cancelled by the organizer at short notice.

3. Execution of services, deviations, cancellations and changes to bookings

3.1. Blue Bug Tours offers participation in organized excursions with a limited number of participants on pre-arranged tours defined over the specified period. The participants will take part in these tours under the supervision of the organizer and submit to the tour as a group.

The rides are neither a racing event nor a rally. Participants are responsible for complying with local road traffic regulations. Participants must ensure that they are fit to drive.

Blue Bug Tours reserves the right, if vehicles provided by Blue Bug Tours are used, to prohibit further travel if it is determined that the participant is unfit to drive. Regardless of any group action, the actions and actions of each participant remain their own responsibility. The participant must always ensure their own safety, the safety of the group participants and the safety of other third parties. The organizer reserves the right to decide on the immediate exclusion of the group in the event of non-compliance.

With justified exclusion from the group, the participant loses any right to further participation, reimbursement of costs or cost compensation for the onward journey / return journey etc. to be borne at his/her own expense.

3.2. Blue Bug Tours organizes the tours to the best of its knowledge and belief. As the organizer of an excursion with an adventure character, Blue Bug Tours assumes no liability for planned or spontaneous deviations from the previously published tour planning. In particular, Blue Bug Tours will endeavor to provide the best possible remedy in the event of road closures, traffic-related deviations or breakdowns and any resulting changes to the schedule, including the tour schedule. However, there is no liability obligation towards the participant with regard to the brochure presentation and explanation. Such incidents are an unavoidable and expected part of the joint excursions.

3.3. Cancellations and changes to bookings must be communicated in writing by e-mail. Cancellations are subject to the following conditions:

- Cancellation more than 3 calendar months before the planned travel date:
Refund of the participation fee minus a processing fee of 25%.
- Cancellation 3 calendar months to 1.5 calendar months before the planned travel date:
Refund of the participation fee minus a processing fee of 50%.
- Cancellation less than 1.5 calendar months before the planned travel date:
No refund possible.

3.4. Changes to bookings (e.g. change of travel date) are only possible after consultation with the organizer and are subject to availability.

3.5. Blue Bug Tours reserves the right to cancel the advertised events CONO SUR 2024 and FUSCA PANTANAL 2025 up to six calendar months before the travel date and BAJA ALPINA 2025 up to five calendar months before the travel date or to change the dates. Any resulting costs incurred by the participant shall be borne by the participant. Cancellations or changes to dates less than six or five

Blue Bug Tours will contact the participants personally within one calendar month before the start of the trip and help to find an amicable solution by providing the participant with proof of the costs incurred.

4. Disclaimer

4.1. The organizer assumes no liability for injuries, damages, losses, accidents or the like that occur during the road trips / excursions, unless they are due to gross negligence or intent on the part of the organization.

4.2. Participants are responsible for complying with all traffic regulations and laws during the road trip/excursion. The organizer assumes no liability for violations of applicable laws by participants.

4.3. The organizer is not liable for any loss or damage to the personal property of participants.

4.4 Concerning the CONO SUR 2024 and the FUSCA PANTANAL 2025: The vehicle rental company assumes repair and maintenance costs to the usual and expected extent. Damage repairs that are clearly attributable to the participant's driving style will be charged at the organizer's cost price or to the participant upon presentation of proof.

Due to their age and local customs, the vehicles are not to be insured beyond the scope of third party liability. In the event of a total loss caused by the participant, the compensation claims to be reimbursed amount to € 6,000.00. This covers all damage to the rented vehicle.

4.4 Concerning the BAJA ALPINA 2025: The participant assumes all costs relating to his vehicle.

5. Insurance

5.1. Participants are obliged to take out suitable travel and health insurance for the road trip/excursion. Only for the CONO SUR 2024 and the FUSCA PANTANAL 2025: Damage in terms of liability insurance is covered by the vehicle rental company's insurance.

6. Vehicle use (ONLY for the CONO SUR 2024 and the FUSCA PANTANAL 2025)

6.1. Participants are obliged to treat the vehicles provided with care and to comply with all applicable traffic regulations and laws.

6.2. Any damage or loss to the vehicles caused by negligence or improper use during the road trip/excursion shall be borne by the participant responsible. In the event of a total loss, the costs to be reimbursed are limited to € 6,000.00.

6.3. Private use of the vehicle for journeys outside the travel times (daily from approx. 06:00 to approx. 19:00) is only possible with the written permission of the organizer. A logbook must be kept for these trips. The range of movement is limited to a maximum of 30 km from the overnight accommodation. The fuel costs incurred for this are to be borne by the participant at a flat rate of € 30.00 per day.

7. Changes to the road trip/exit

The organizer reserves the right to change the road trip/excursion for reasons of force majeure or unforeseen circumstances. In this case, the organizer will do its best to offer alternative solutions or refund any fees already paid.

8. Data protection

The data protection guidelines of the organizer are based on the General Data Protection Regulation.

9. Use of video and audio recordings of the excursions and evening events by the organizer

9.1. Declaration of consent to the use of image and sound recordings: The participant expressly agrees that the organizer may make video and audio recordings of the participants during the rides and the associated breaks and evening events. The participant grants the organizer the unrestricted right to use the image and sound recordings made for advertising purposes, including but not limited to use in print media, on websites, in social media, on posters, in brochures and in other advertising materials. The same applies to image and sound recordings of other participants.

9.2. Intended use: The image and sound recordings made may be used for the following purposes, without being limited to them:

- Advertising and promotion of the organizer and its services.
- Public announcements, including press releases and publications in the media.
- Participation in competitions or events.
- Other purposes related to the promotion and advertising of the organizer's activities.

9.3. Waiver of remuneration and claims: The participant waives any remuneration, compensation or license fees for the use of the image and sound recordings by the organizer. The participant waives any claims that may arise from the use of the image and sound recordings by the organizer, including claims to personal rights, data protection or copyrights.

9.4. Transfer of rights and duration: The participant agrees that the rights to the image and sound recordings are transferred to the organizer and that this transfer is permanent and irrevocable.

9.5. Revocation of the declaration of consent: The participant has the right to revoke his/her declaration of consent to the use of image and sound recordings at any time in writing to the organizer. In this case, future recordings of the participant will no longer be used for advertising purposes, but recordings already made will remain unaffected.



10. Place of jurisdiction and applicable law

10.1. These GTC are subject to German law.

10.2. The place of jurisdiction for all disputes in connection with these General Terms and Conditions and the road trips/excursions is the registered office of the organizer. By booking and participating in the organizer's road trips/excursions, participants declare their agreement with these General Terms and Conditions. The organizer reserves the right to change these terms and conditions at any time.

11. Final provisions

11.1. These GTC come into force with the participant's booking/reservation request and are valid indefinitely. Updates will be [published](#) on the homepage www.bluebugtours.com.
